The pride of the Salem's humans in the novel "Crucible" by Miller leads to

The novel of "Stone Angel" is dedicated to the consequences of pride. These scientists again proved the evil of pride in their work very skillfully. This scientist said that pride keeps us away from God. Pride means arrogance and it is regarded as a very bad vice among people.

There are a lot of information about pride in Bible. Arrogance is also condemned in religion because it is pride. And one example from Bible: With pride comes only strife... "Proverbs 13:10 from the Bible".

Despite of dividing types, Those scholars said that we can emphasis on four theories of pride and we shouldn't forget about this. These theories are: Authentic and hubristic pride are two different emotions. Authentic and hubristic pride are two types of pride that have positive and negative valence , respectively. Pride is made up of two types of activation: high activation and low activation. While hubristic pride is a personality attribute that identifies a person who has a predisposition to experience pride across contexts and throughout time, authentic pride is a state emotion that arises in response to a particular triggering event. Isabella Poggi and Francesca D'Errico's opinions that they divided

Superiority

*Arrogance"*⁸.

In their work, Isabella Poggi and Francesca D'Errico explained the reasons why the types of pride are divided into three types. According to Ronald McDonald's ideas " *pride is divided into four groups they are :*

Pride of knowledge

Pride of power

*Pride of appearance"*⁹

Everyone comes across that kind of people who are proud and with that kind of people, they face many nuances and complexities in their life that is not straightforward.

Discussion: In this part, we can discuss the work of pride in literature. Firstly, we start from " *Pride and Prejudice* " by Jane Austen. The narrative describes a young woman named Elizabeth and her" adventures "while looking for marriage and love. Families belong to Bennet, Darcy and Bingley are crucial to the story's plot. In that story, Mr Darcy is described as a proud man. At the beginning of the story, when he rejects to dance with Elizabeth, he comes across to the reader as annoying and arrogant. And his arrogance is evident in the third chapter of the story, *she is torerable, but it is not enough to attract me, I don't desire to be that kind of women. That's why , don't talk about her"*(138p). These words are said by Mr Darcy to his friend. Despite of Mr Darcy's pride, the story ends with the love of them. They fall in love. Jane Austen explained the concept of pride very skillfully in this work and through the characters who described the loss of pride when faced with some challenges or unable to fall in love.

Arthur Miller described pride in his work of "Crucible". In that story, pride is described with the help of main characters who are John Proctor and Elizabeth. They don't comprehend with each other. People with pride has some kind of risks that they are losing everything and everyone. John Proctor is a proud man who is ready to do anything in order to clear his proud name of all accusations. And Her womanly pride had caused a distance with his husband. Because of her womanly pride, they have problems related on their relationships. We can see Elizabeth's pride in these words: *"I can't forgive you John"(139p).* These actions lead to many understandable situations and complication. To tell the truth, Arthur Miller described pride very successfully.

Conclusion: we have reviewed the works of many scientists on the concepts of pride. And the opinions many scientists all over the world is bad about pride and its negative consequences are depicted in their works through the characters. Pride is not condemned in modern times, it was considered one of the vices that have been hated by people for many years. We can see the proof of this in the Holly book of Islam religion, the Koran, and the Bible of Christians. We know for sure that these are books from approximately 15 centuries ago.
